RULES AND REGULATIONS

1. There is no limit as to the number of entries to the festival provided that all of them must be the entrant's/firm's/institute's original work and shall not infringe on any copyrights or any other rights of any third parties.
2. Contestants agree that they have obtained all required permissions regarding music, sound and/or images presented in your short film. By entering the festival, the entrant agrees EKTA will not be held liable for any copyright infringements perpetrated by you or your short film.
3. The medium in which the short film seeking entry can be any language.
4. Entry fee per film is fixed at the rate Rs.1000/- (One Thousand Only) which is non- refundable and it shall be payable by Cash, Bank Deposit, Demand Draft or Money Transfer/ NEFT in favor of EKTA.
5. The jury judging the merits of the film admitted to the festival will consist of prominent actors/directors/technicians of the film industry.
6. The entry should be send in a DVD. The format of the short film seeking entry to the festival shall be DVD, MOV, AVI or MP4.
7. From out of the total entry only selected short film adjudged by the jury shall be qualified to be exhibited/projected/broadcasted/ telecasted at the principal venue. The decisions of the jury in selecting these entries cannot be disputed by the entrance on any score.
8. From the selected short films thus exhibited the jury will decide the award winning short Films and individual awards.
9. The maximum duration of the short film shall be only 45 minutes
10. The participating entrance/producers will be issued 2 delegate passes for the festival. Only applicants with delegate passes will be eligible to attend seminars, open forums and enjoy other delegate concessions.
11. The Selected short films will be displayed by the channel partner, by giving due credit to the participant.
12. The venue and timings of the event are liable to be altered depending on the circumstances and to the choice to the organization, EKTA
13. The organizers are not in any manner liable for any technical or operational issues of the short film format and, in any event, if any entry could not be exhibited in the events, a second chance will not be afforded to the entrance to substitute the defective format.
14. Any entry from any schools or other educational institutions shall be brought through the written application with the affidavit signed by the head of the institution.
15. The last date of receiving the entries is 17th March 2015.
16. The awards of the EKTA Short Film Festival 2015 will be announced only at the mega event, and no quarries in this regard will be entertained before the mega event.
17. The Festival Committee will not be sending back the DVDs to the participants.
18. EKTA Short Film Festival reserves the right to not screen any film(s) for any reason it deems valid.
19. The entrants may also run the risk of being prosecuted as per the Indian Criminal Procedure Code and the Indian Media Law for any offence or infringement. Racial, religious and regional discrimination shall not be portrayed in any part of the film being submitted.
20. In any matter concerning the subject the decision of the jury will be final and will not be subject to any appeal.
21. The jurisdiction with regard to any dispute interse will be only in Calicut Courts.
22. EKTA Short Film Festival organizing, selection committee members, juries are not allowed to compete in the respective festival.
